

Why I believe the AFGE's lawyers do not have all the facts

Hi Holly,

After I retired in 2010, President Barack Obama declared my records secret/confidential business information for a very good reason. One of those records included my website with 30+ named whistleblower scientists, doctors, engineers, lawyers, accountants, and other disciplines that exposed how Congress and 4 prior presidents (Reagan – George W. Bush) had created the 2008 economic crisis. I had that information because (like our 6/27 meeting) we shared our stories among ourselves, also with a game plan for exposing both parties' lawless acts. 2 of those documents include: (1) a 77 whistleblower Petition to Congress demanding that Congress enforce its own whistleblower protection laws, to no avail, and (2) in 2005, like-minded whistleblower lawyers financed a 100+ whistleblower dissent event at the Watergate Hotel in Washington, D.C. where I was one of several whistleblower speakers. There is no better way to impeach President Donald Trump than for the AFGE to work with these whistleblowers, also mostly retired civil servants, like me. If you are interested, I know several of those whistleblowers and they could share their stories during one of your AFGE events.

Both of those 2 above dissent events failed to get the media's attention, as we had planned, because the richest 1% had controlled both the government and the media sources of misinformation, both within the government and the media, even before the 2008 economic crisis, and for 5 key reasons that describe: **(1)** how both parties had begun secretly and systematically eliminating all levels of dissent as far back as the 1960's, per a Nixon-era/Malek Manual, **(2)** how both parties covered up their lawless acts by giving Wikipedia gross levels of misinformation (like an Ernie Fitzgerald whistleblower link), **(3)** How both parties used Congress' unnecessary 1978 Civil Service Reform Act (CSRA) to destroy our 99%'s democracy also with gross levels of missing and inaccurate information, **(4)** how Congress' March 22 Whistleblower Protection Act feigned the protection of whistleblowers with the exact opposite intent, and **(5)** why today's \$7 trillion annual federal budgets could hide as much as 50% in waste (corruption) because the government has not had money (audit) trails for 237-years (1789 – 2026), and no ability to responsibly manage the government. That's because America's politicians created their political AICPA in 1887 to create accurate private sector financial statements while using that same AICPA to prevent those same private sector money (audit) trails for all federal, state/local governments to hide how Presidents, Governors, and Mayors spend their citizen's tax dollars, also confirmed by Bill Gates for those state governments. That's the bad news!

The good news is that there is a single source of accurate information that does record the truth, and that the AFGE's lawyers can easily validate because they already have the contact information of the retired civil servant whistleblowers in my website below. These retired civil servants are also an invaluable resource to expose how both parties' used *Congress' unnecessary 1978 lawless CSRA law* to: **(1)** force the 119th Congress immediate impeachment of President Trump, Vice President JD Vance, and his technically unqualified Cabinet, **(2)** dramatically cut the cost of not just the federal government but state, and local governments, and **(3)** take the lead in strengthening all federal, state, and local government unions, and that President Ronald had begun weakening in the 1980's, and that continues with Trump.

After President Barack Obama declared my records secret, I spent the last 15+ years of my retirement expanding upon my initial website to include more whistleblowers, and to use my college accounting degree to create a *single democratic business accounting model* with the sole intent of ending the routine rise and fall of governments since the beginning of time. Corporations have business models to ensure their success and there was (and is) no reason why all worldwide citizens cannot work together to use that *single democratic business accounting model* to create democracies where citizens have:

- (1)access to the same levels of information as their politicians, on a real time basis, and 242
- (2)an accurate accounting of how their Presidents, Governors, Mayors, and world leaders spend their citizen's tax dollars, also the exact opposite way that governments work

This is also why I created America's Bottoms Up Democratic Business Model website that includes 47 named whistleblower scientists, doctors, engineers, lawyers, accountants, and other disciplines within 27 departments, bureaus, and agencies to record both parties' lawless acts, and that also explains how that *single democratic business accounting model* was also illegally prevented.
